

## The El Hiblu 3

In March 2019, Amara, Kader, and Abdalla – known as the El Hiblu 3 – first set foot in Malta. They were only 15, 16, and 19 years old. They could have never imagined that, five years on, they would still be stuck in this nightmare. Nine charges hang over them, preventing them from living dignified, free lives.

In the days before their arrival in Malta, the El Hiblu 3 helped to defuse a volatile situation at sea. Together with 100 other people, who escaped from violence in Libya, they were rescued by an oil tanker, the El Hiblu. When the captain attempted to return the rescued people to Libya, the people on board the El Hiblu 1 protested. Abdalla, Amara, and Kader acted as translators and mediators between scared migrants and a scared crew. Being the only ones who spoke enough English to converse with the captain.



## The indictment

After 55 months of hearings, waiting, and evidence gathering, the Attorney General's office filed harsh charges against the three young men in November 2023. If the El Hiblu 3 are convicted, they face long prison sentences.

"In defence of our lives, we resisted by protesting and I, along with two others, served as translators because we had some basic knowledge in English. We did not do this with any bad intentions and we have no plans to pose threats or danger to the people of Malta." – Amara

## The legal background

The international law of the sea says: "People rescued from distress at sea have to be taken to a place of safety". Under no circumstances can Libya be considered a safe port for migrants. Even the United Nations and the European Commission agree on that. In January 2017, an internal report of the German embassy in Niger described 'concentration-camp-like' conditions in Libya's detention prisons.

No one on the ship was harmed. Over 100 people were not returned to violence, slavery, rape in Libya. In Malta's territorial waters the ship was stormed by the Armed Forces who found no violence going on, but in fact a ladder hanging down the ship for them to onboard. Yet, upon arrival at Broilers Wharf in Senglea the El Hiblu 3 were arrested and accused of hijacking the ship, threatening its crew, and engaging in terrorist activities.

## L-El Hiblu 3

F'Marzu tal-2019, Abdalla, Amara u Kader – magħrufin bħala l-El Hiblu 3 – rifsu għall-ewwel darba fuq Malta. Kell-hom biss, 15, 16 u 19-il sena rispettivament. Qatt ma set-għu jobrsu, li ħames snin wara, sejkun għadhom jgħixu ħmar il-lejl. Fuq rashom hemm imdendla disa' akkuži li jwaqqfuhom milli jgħixu ħajja dinjituża u ħielsa.

Fil-jiem qabel waslu Malta, l-El Hiblu 3 għenu biex jikkal-maw sitwazzjoni volatili fuq il-baħar. Kienu ġew salvati minn tanker taż-żejt, l-El Hiblu, flimkien ma' 100 oħra li ħarbu mill-vjolenza fil-Libja, fosthom 19-il mara u 12-il tifel u tifla. Meta l-kaptan ipprova jibgħathom lura lejn il-Libja, dawn ippitestaw. Abdalla, Amara, u Kader għamluha ta' tradutturi u medjaturi bejn il-migrant u l-ekwipaġġ. It-tnejn li huma kienu mbeżgħha. L-El Hiblu 3 kieni l-uniċi li kieni jitkellmu biżżejjed Ingliż biex setgħu jitkellmu mal-kaptan.



## L-akkuža

Wara erba' snin u nofs ta' seduti kull xahar, stennija, u ġbir ta' evidenza, f'Novembru tal-2023, l-Uffiċċju tal-Avukat Ĝenerali ressaq akkuži horox kontra dawn it-lieħ t-żgħażaq. Jekk l-El Hiblu 3 jinstabu ħatja, jaffaċċjaw sentenzi twal ta' priġunerija.

"Biex nissal vagwardjaw ħajjitna, irreżistejna billi pprotestajna u jien, flimkien ma' tnejn oħra, għamilnieha ta' tradutturi, ghax konna nafu fit-Ingliz bażiku. Ma għamilniex dan b'intenzjonijiet ħżiena u ma għandna ebda pjani li nkunu ta' theddida jew periklu għall-poplu Malti." – Amara

## Il-qafas legali

Il-liġi internazzjonali tal-baħar tħid, "Persuni savlati minn distress fuq il-baħar għandhom jittieħdu f'post sigur." Il-Libja, taħbi ebda ċirkustanza ma tista' titqies bħala port sigur għall-migrant. Il-Ġnus Magħquda u l-Kummissjoni Ewropea wkoll jaqblu fuq din. F'Jannar tal-2017, rapport intern tal-Ambaxxata Ĝermaniża fin-Niger iddeskriva l-kundizzjonijiet fiċ-ċentri ta' detenzjoni tal-Libja bħala simili għal "kampjiet tal-konċentrément."

Ebda persuna li kienet fuq il-vapur ma ndarbet. Aktar minn 100 persuna ma ntabgħi lura lejn vjolenza, skjavitù u stupru fil-Libja. Fl-ibħra territorjali ta' Malta, il-vapur inqabbad mill-Forzi Armati li ma sabu ebda vjolenza għaddejha fuq il-vapur, anzi sellum imdendel biex permezz tiegħu jitilgħu fuq il-vapur. Madankollu, meta l-El Hiblu 3 waslu l-Isla fi Broilers Wharf, ġew arrestati u akkużati li ħatfu il-vapur, hedw lill-ekwipaġġ u li kienu involuti f'attivitàet terrorističi.
